## **CLUB EVENT RELEASE FORM; ASSUMPTION OF RISK**

<u>RELEASE</u>: The undersigned (on my own behalf and on behalf of my heirs, personal representatives, successors and assigns), for and in consideration of the opportunity to participate in any function or "Activity" (hereinafter, **EVENT(S)** sponsored and/or conducted by the **SUN CITY ROSEVILLE SENIOR SOFTBALL CLUB**and its respective officers, directors, employees and agents including the Sun City Roseville Community Association (hereinafter, the "RELEASED PARTIES") releases and holds harmless the "RELEASED PARTIES" from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have against the "RELEASED PARTIES" in any way resulting from, arising out of, or in connection with the performance of their club duties and my participation in any said **EVENT(S)**.

This Release extends to any and all claims I have or later may have against the "**RELEASEDPARTIES**" resulting from or arising out of their performance of their club duties whether or not such claims result from negligence (except willful neglect) on the part of any or all of the "**RELEASEDPARTIES**" with respect to the **EVENT(S)** or with respect to the conditions, qualifications, instructions, rules or procedures under which the **EVENT(S)** are conducted or from any other cause, as well as claims arising from the facilities (and equipment and items therein) where the EVENT(S) take place, including without limitation buildings, rooms, parking lots, restrooms, hallways, seating, landscaping, patios, and walkways. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE **"RELEASED PARTIES"** FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH THE PERFORMANCE OF THEIR CLUB DUTIES IN SPONSORING, PLANNING OR CONDUCTING THE EVENTS.
